The pre-consumer and post-consumer recycled material content of the following Fi-Foil Company, Inc. products has been verified for the period July 1 to September 30, 2023, by R&D Services, Inc., a third-party testing, and inspection service operating in compliance with ISO 17025 (TL-566) and ISO 17020 (AA-712).

The verified weight % pre-consumer and post-consumer recycle contents for each of the above nine products are listed in **Attachment 1**. The recycle content is obtained from pre-consumer content weighted 50 % with post-consumer content weighted 100 %. The product verifications are based on the recycle content of the components used to produce each product and the confirmation of a balance between incoming materials and manufactured items. Manufacturing and inventory data for the compliance period were provided by Fi-Foil Company, Inc. on October 10, 2023. The most recent on-site review was completed on December 9, 2022.
